For all tours booked at least 104 days prior to departure, all monies paid to Ayelet are fully refundable if cancelled by traveler within 14 days of booking. EXCEPTION: If tour is canceled by Ayelet Tours/Hadassah due to a circumstance beyond our control more than 90 days before departure, registrants can either transfer their deposit to another Hadassah tour in the next 2 years or their deposit will be fully refundable. If tour is canceled by Ayelet Tours/Hadassah due a circumstance beyond our control within 90 days of departure, registrants can choose to either transfer their funds in full to another Hadassah tour in the next 2 years or choose to receive a full refund minus up to \$300 in administrative/non-refundable costs, which may include applicable credit card fees and cancellation penalties charged by subcontractors such as airlines, hotels and other special events related vendors.

NOTE: Advertised group pricing is based on a minimum number of paying participants unless otherwise noted on the promotional materials. If fewer participants travel, a small per person group supplement may apply.
